2. OBLIGATIONS DEFINED. The term "Obligations" is defined as and includes the following:

A. A promissory note, No. ______(Note) dated April 1, 1998, and executed by JO IN GODLEY and PATRICK GODLEY (Borrower) payable in quarterly payments to the order of Bank, which evidences a loan (Loar) to Borrower in the amount of \$250,000.00, plus interest, and all extensions, renewals, modifications or substitutions thereo.



B. Owner has recorded the Leases as required by law or as otherwise product for the type and use of the Property.





B. To recover reasonable attorneys' fees to the extent not prohibited by taxi.

C. To declare the Obligations immediately due and payable, and, at Bank's option, (100 lise any of the remedies provided by law, the Note, the Mongage or this Agreement.

D. To enter upon, take possession of, manage and operate all or any part of the Property, make, modify, enforce or cancel any Leases, evict any Lessee, increase or reduce Rent, decorate, clean and make repairs, and up any act or incur any cost Bank shall deem proper to protect the Property as fully as Owner could do, and to apply any fund's collected from the operation of the Property in such order as Bank may deem proper, including, but not limited to, payment of the following: operating expenses, management, brokerage, attorneys' and accountants' less, the Obligations, and toward this maintenance of reserves for repair or replacement. 

(2) "Hazardous Substance" means any toxic, redicactive or hazardous material, waste, pollutant or contaminant which has characteristics which render the substance dangerous or potentially dangerous to the public health, safety, welfare or the environment. The term includes, without limitation, any substances defined as "hazardous material," "toxic substances," "hazardous waste" or "hazardous substance" under any Environmental Law.



 - D. INTEGRATION CLAUSE. This written Agreement and all documents executed concurrently herewith, represent the entire understanding between the parties as to the Obligations and may not be contradicted by evidence of prior, contemporaneous, or subsequent oral agreements of the parties.
 - E. FURTHER ASSURANCES. Owner agrees, upon request of Bank and within the time Bank specifies, to provide any information, and to execute, acknowledge, deliver and record or file such further instruments or documents as may be



required by Bank to secure the Note or confirm any lien.
