ASSIGNMENT OF LANDLORD'S INTEREST IN RENTS AND LEASES

Any such sums advanced or paid by Assignee, together with interest thereon at the Note Rate shall be payable on demand, shall be secured by this Assignment and the other Loan Documents and shall be added to the liability of Assignor to Assignee in respect of the Loan. The failure of Assignor to so reimburse Assignee shall constitute an Event of Default. This paragraph shall survive the

(C) obtain and evict tenants and fix or modify rants.
