That on or about September 16, 1997, the owners owned the described land, known as Holiday Inn Express, located at 16900 S. Halsted, County of Cook, Harvey, Illinois, a copy of which legal description is attached hereto as Exhibit "A", and Madan Construction was the owner's contractor for the improvement thereof.

That on or about September 16, 1997, said contractor made a subcontract with the claimant to furnish the following materials, which include but are not limited to paint and paint related materials, hereinafter "the materials", which were incorporated for the improvement of the above described property, and that on February 5, 1998, the claimant completed the contract thereunder by delivering the materials to Spray Line Products Inc., and the value of the materials is One Thousand Four Hundred Ninety Four Dollars and Twenty Nine Cents (\$1,494.29).

That said Spray Line Products Inc. is not entitled to any credits on this account, and there is now due, unpaid, and owing to the claimant, after allowing all just credits, the sum of One Thousand Four Hundred Ninety Four Dollars and Twenty Nine Cents (\$1,494.29) with interest, for which the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due to the contractor from the owner.

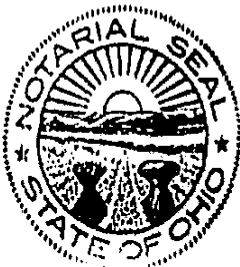
