FINDS THAT:

1. Plaintiff is entitled to judgment on the \$5,000 note which is the subject matter of Count II, that no payment on said note has been made, and that the filing of the complaint on July 12, 1995 constituted a formal demand for payment, notwithstanding any previous waivers that defendants have asserted, thus establishing a date from which interest can be calculated; and:
2. That simple interest at the rate of 15% for the 17 months from July 12, 1995 to December 12, 1996 is \$1062.50; and
