

AMENDMENT TO MORTGAGE

THIS AMENDMENT made as of the 1st day of March, 1998 by and between FIRST NATIONAL BANK OF EVERGREEN PARK, not personally, but as Trustee U/T/A dated December 19, 1966 and known as Trust No. 9450 (hereinafter referred as "Mortgagor") and TCF NATIONAL BANK ILLINOIS, successor by merger to Capitol Federal Savings of America (hereinafter referred to as "Mortgagee").

WITNESSETH:

WHEREAS, the Mortgagee is the holder and owner of a certain Mortgage (hereinaster referred to as the "Mortgage") securing a Note (hereinaster referred to as the "Note") in the original principal sum of Six Hundred Thousand and 50'100 Dollars (\$600,000.00) from the Mortgagor dated August 1, 1988 payable to the order of the Mortgagee; and

WHEREAS, the Mortgage was recorded August 9, 1985 with the Recorder of Deeds of Cook County, Illinois as document No. 88358249 and conveyed the real estate described below:

WHEREAS, the Note has been previously modified pursuant to a certain Modification Agreement dated December 30, 1988 amending the monthly payment amount and payment date on the Note and further modified by a certain Modification Agreement dated December 21, 1992 amending the maturity date and certain other terms of the Note; and

WHEREAS, the parties desire to further modify the maturity date and certain other terms of the Note to provide for full repayment of all indebtedness secured by the Mortgage on or before March 1, 2008.

NOW THEREFORE, in consideration of Ten and no/100 Dollars (\$10.00) and other good and valuable consideration, receipt of which is hereby acknowledged, and in further consideration of the mutual promises contained herein, Mortgagee and Mortgagor agree as follows:

- 1. The Maturity Date of the Note as reflected on the Mortgage is hereby changed to March 1, 2008. Mortgagor will make monthly payments until March 1, 2008, at which time the entire remaining balance including any deferred interest and other charges due under the Note, as modified, will be fully due and payable.
 - 2. This Agreement shall be attached to and made a part of the Mortgage.
- 3. Mortgagor warrants that the Mortgage, as modified hereby, is a valid, first and subsisting lien on the real estate, binding and enforceable according to its terms.
