(the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 705 11TH ST #203
WILMETTE, IL 60091

The Property includes a unit in, together with an undivid diaterest in the common elements of, a condominium project known as: VILLAGE CENTRE

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

CONDOMINIUM COVENANTS. In addition to the covenants and agreements incide in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- (i) Lender waives the provision in Uniform Covenant 2 for the monthly payment to Lender of the yearly premium installments for hazard insurance on the Property, and
