In the event of any conflict between the arbitration provisions of this Security Instrument and the provisions of any other Loan Document or agreement between Lender and Borrower, the provision of this Security Instrument shall control.
- (f) This Section 42 shall survive the termination, satisfaction, invalidation or reconveyance of this Security Instrument.
