THE COVENANTS, CONDITIONS AND PROVISIONS PREVIOUSLY PEFERRED TO ARE:

1. Mortgagors shall (a) promptly repair, restors and rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good correction and repair, without waste, and free from mechanic's or other lieus or claims for lieu not expressly subordinated to the lieu bereof; (c) pay when due any indebtodness which may be secured by a lieu or charge on the premises superior to the lieu bereof; (c) pay when due any indebtodness which may be secured by a lieu or charge on the premises superior to the lieu bereof; (d) supplies within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (e) supply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material elections in said premises except as required by law or municipal ordinance.

4.
