THIS INDENTURE WITNESSETH that the Grantor, Venter & Associates, Inc. - Illinois Corporation of the County of Cook and State of Illinois, for and in consideration of 5 Dollars, and other good and valuable considerations in hand paid, CONVEY AND WARRANT 5 unto AUSTIN BANK OF CHICAGO, an Illinois Banking Corporation, Chicago, Illinois, as Trustee under the provisions of a trust agreement dated the 9th day of September 19 97, known as Trust Number 712, the following described real estate in the County of Cook and State of Illinois, to-wit:

the terms of the trust have been complied with, or be authorized to inquire into the validity or effect of any act of the trustee, or be obliged or privileged to inquire into any of the terms of the trust agreement; and every deed, trust deed, mortgage, lease or other instrument executed by the trustee in relation to the real estate shall be conclusive evidence in favor of every person relying upon or claiming under any such conveyance, lease or other instrument, (a) that at the time of the delivery thereof the trust created herein and by the trust agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained herein and in the trust agreement or in any amendments thereto and binding upon all beneficiaries, (c) that the trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all title, estate rights, powers, authorities, duties and obligations of him, his or their predecessor in trust.

The interest of each beneficiary under the trust agreement and of all persons claiming under them or any of them shall be only in the possession, earnings, and the avails and proceeds arising from the sale, mortgage or other disposition of the real estate, and such interest is hereby declared to be personal property, and no beneficiary shall have any title or interest, legal or equitable, in or to the real estate as such, but only an interest in the possession, earnings, avails and proceeds thereof as aforesaid.

And the said grantor hereby expressly waive 5 and release 5 any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
