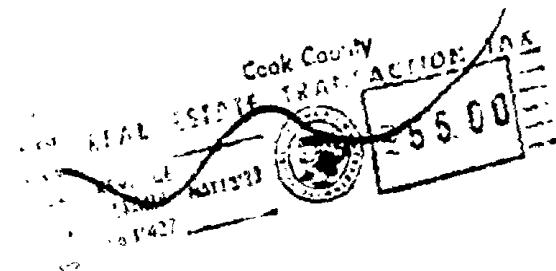
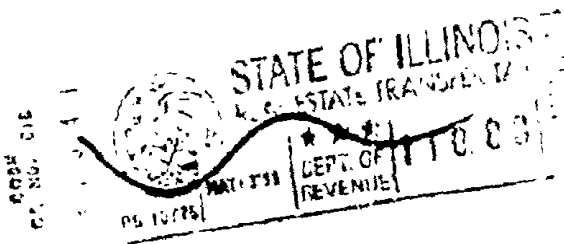
LEGAL DESCRIPTION for the property commonly known as Unit 5247-3B, 5247-3-47 South Michigan Avenue, Chicago, Illinois:

PARCEL 1: UNIT 5247-3B IN THE MICHIGAN TERRACE CONDOMINIUM AS DELINEATED ON A SURVEY OF THE FOLLOWING DESCRIBED REAL ESTATE:
