UNOFFICIAL COPY 326 SECOND AMENDMENT TO AMENDED AND RESTATED REDEVELOPMENT AGREEMENT

This Second Amendment to Amended and Restated Redevelopment Agreement is entered into as of the 8th day of September, 1998, by the Village of Arlington Heights, Illinois ("Village"), M & J Wilkow, Ltd. ("Wilkow"), and General Electric Capital Corporation ("GECC").

Recitals

- A. The Village, Wilkow and GECC have entered into an Amended and Restated Redevelopment Agreement dated as of December 15, 1997, ("Redevelopment Agreement"), which pertains to the implementation of the Rand Road/Arlington Heights Road Redevelopment Plan. A First Amendment to the Amended and Restated Redevelopment Agreement was subsequently approved on August 3, 1993.
- B. Due to changed facts and circumstances upon which certain provisions of the Redevelopment Agreement were based, the parties desire to further amend the Redevelopment Agreement as is hereinafter set forth.

NOW, THEREFORE, in consideration of the Recitals, and for other good and valuable consideration, the receipt and adequacy of which are acknowledged hereby, the parties hereto do hereby amend the Redevelopment Agreement as follows (it being understood that all capitalized terms used herein shall have the meanings given to them in the Redevelopment Agreement):

Agreements

- 1. The date in which the Relocation Agreement (Approved by the Village and GECC, as is required by the Redevelopment Agreement) is to be fully executed shall be extended from September 8, 1998 (as set forth in the First Amendment to Amended and Restated Redevelopment Agreement) to September 28, 1998.
- 2. Except as amended hereby, the Redevelopment Agreement is hereby ratified and confirmed and shall continue in full force and effect.
