RESTATED REDEVELOPMENT A

This Fourth Amendment to Amended and Restated Redevelopment Agreement is entered into as of the 16th day of November, 1998, by the Village of Arlington Heights, Illinois ("Village"), M & J Wilkow, Ltd. ("Wilkow"), and General Electric Capital Corporation ("GECC").

Recitals

- A. The Village, Wilkow and GECC have entered into an Amended and Restated Redevelopment Agreement dated as of December 15, 1997, ("Redevelopment Agreement"), which pertains to the implementation of the Rand Road/Arlington Heights Road Redevelopment Plan. A First Amendment was approved August 3, 1998, a Second Amendment was approved September 8, 1998 and a Third Amendment was approved on September 28, 1998.
- B. Due to changed facts and circumstances upon which certain provisions of the Redevelopment Agreement were based, the parties desire to further amend the Redevelopment Agreement as is hereinafter set-forth.

NOW, THEREFOR i. in consideration of the Recitals, and for other good and valuable consideration, the receipt and adequacy of which are acknowledged hereby, the parties hereto do hereby amend the Redevelopment Agreement as follows (it being understood that all capitalized terms used herein shall have the meanings given to them in the Redevelopment Agreement):

Agreements

- 1. In Section 5 of the Amended and Restated Pedevelopment Agreement, the following sentence is added after the first sentence in the paragraph: "Either Wilkow or GECC shall reissue their existing Letter of Credit for an additional \$111,000 prior to receiving reimbursement from the Village in excess of \$2,915,000 for Eligible Up Front Costs."
- 2. In Section 8(d) of the Amended and Restated Redevelopment Agreement, the amount that the Village shall pay for Eligible Up Front Costs, is changed from \$2.515,000 to \$3,026,000.
- 3. Except as amended hereby, the Redevelopment Agreement is hereby ratified and confirmed and shall continue in full force and effect.
