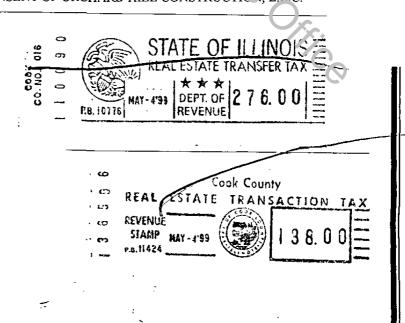

FENCES: No fence or other non-residential structure shall be enected or maintained on any lot in the Subdivision which shall restrict the view in any way from an adjoining lot in the Subdivision. The fence, when necessary, should be designed to enhance rather than detract, from the overall appearance of the property.
