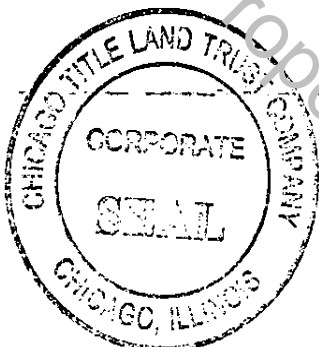

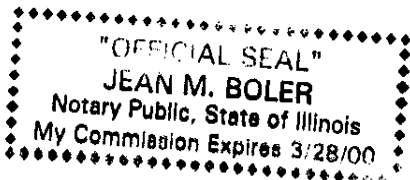


EXHIBIT "A"
Legal Description

Lot 2 in Theodore E. Frenden's Subdivision in the Northeast $\frac{1}{4}$ of Section 29, Township 40 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois;
