3. Notice was published in the Chicago Sun-Times in Chicago, Illinois, from DECEMBER 20, 1998 through DECEMBER 22, 1998.

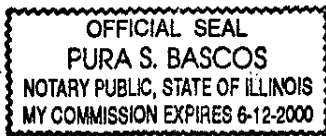
