2. The powers granted above shall not include the following powers or shall be modified or limited in the following particulars: No limitations.

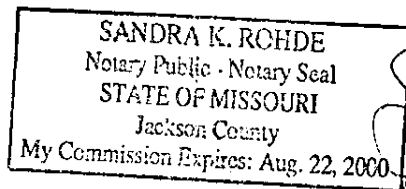
3. In addition to the powers granted above, I grant my agent the following powers: To execute all documents and perform all acts that are necessary to effectuate the sale of the above referenced real estate.

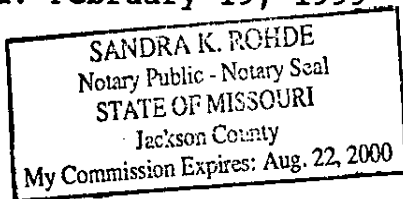
