LOAN MODIFICATION AGREEMENT

DATE: February 18, 1999

WHEREAS, the undersigned owner of said premises does hereby request this Loan Modification Agreement.

NOW, THEREFORE, it is hereby agreed by the parties hereto that the original sum upon the date of this Agreement is increased to One Hundred Thousand and 00/100 Dollars (\$100,000.00); which the undersigned promises to pay with interest at one-half percent (0.5%) in excess of the Prime Rate of interest announced by the Wall Street Journal, and that the said indebtedness, shall be payable in payments of interest only monthly, beginning in March, 1999, until said indebtedness is paid in full, except that any remaining indebtedness, if not sooner paid, shall be due and payable February 18, 2004 and that in all other respects said mortgage shall remain in full force and effect and the undersigned, his or their heirs, assigns and representatives, shall be obligated to pay the same.

Current Representations and Varranties. To induct the Bank to enter into this Agreement, the Borrower hereby represents and warrants to the Bank as follows:

- c. Continued Accuracy. Each and every representation and warranty made by the Lorrower in favor of the Bank in connection with the Loan remains accurate in all respects, subject only to changes expressly permitted by the Bank.

Reaffirmatical. To the extent any term(s) or condition(s) in the Note, the Mortgage, or any of the Loan Documents shall contradict or be in conflict with the amended terms of the Loan as set forth herein, such terms and conditions are hereby demed modified and amended accordingly, upon the effective date hereof, to reflect the terms of the Loan as so amended herein. All terms of the Note, the Mortgage, and the Loan Documents, as amended hereby, shall be and remain in full force and effect and shall constitute the legal, valid, binding and enforceable colligations of the Borrower of the Bank. Upon the effective date hereof, the Borrower herein restates, ratifies and reaffirms each and every term and condition set forth in the Note, the Mortgage, and the Loan Documents as amended herein. The Borrower hereby acknowledges and agrees that, as of the date hereof, there exists no right of offset, defense, counterclaim or objection in favor of the Porrower as against the Bank with respect to the Borrower's obligations.
