LIMITED POWER OF ATTORNEY



KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Bankers Trust Company, a National Banking Association, having an office located at 3 Park Plaza, 16th Floor, Irvine, CA, is Trustee of the following mortgage loan trusts (the "Trusts"), see Exhibit "A".

 - d. Escrow instructions;
 - e. Any and all documents necessary to effect the transfer of property.
