Section 8.16.050 Weed Removal by Village: "Should any owner refuse or neglect to comply with any notice provided for hereinabove, the Village or its agents shall enter upon such real property and shall cut or destroy any such noxious weeds or improper growth of weeds or grasses. Any cost thereof shall be paid by the owner of such real property."

That on August 3, 1998, the owners of the above-described property were notified in writing in accordance with the above-mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.

That on <u>August 12, 1998</u>, the VILLAGE OF LEMONT caused said weeds to be cut, removed and destroyed, and the reasonable cost and expense incurred for the work was <u>TWO</u>
