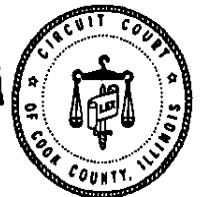

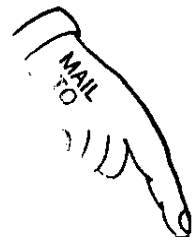
**ORDINANCE

ORDINANCE  
OF THE CITY COUNCIL OF THE CITY OF PARK RIDGE  
LEVYING A SPECIAL TAX FOR SIDEWALK REPAIR

WHEREAS, the City of Park Ridge has for many years maintained a voluntary "share-the-cost" program for repairing defective and deteriorated sidewalks, pursuant to which the cost of such repair has been shared by the City and the owner of the abutting property; and

WHEREAS, this program has resulted in some areas of sidewalk deteriorating to the extent that they may constitute a hazard to public health and safety due to the failure or refusal of the abutting property owner to participate in the "share the cost" program; and

WHEREAS, the Director of Public Works has inspected all deteriorated sidewalks in the City and has identified those which are in the greatest need of immediate repair; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 5/11-84-1 et. seq., provides that the cost of construction and repair of sidewalks may be paid by a special tax levied upon the owner of the land abutting the sidewalk.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Park Ridge that a Special Tax is hereby levied for the purpose of sidewalk construction and repair in accordance with 65 ILCS 5/11-84-1 et. seq., on such property and in such amounts as are hereinafter described:

1. The sidewalks or portions thereof to be constructed or repaired during the 1999-2000 fiscal year are set forth in Appendix "A" hereto. The sidewalks are hereby declared to be so related as to constitute a single system of improvement by virtue of the fact that a single contract is to be let for all the work.
2. The Special Tax is levied in the amount of thirty-two dollars (\$32.00) for each five (5) feet (a "square") of front footage of sidewalk repaired on each lot described in Appendix "A" adjoining the sidewalk, but not to exceed three hundred twenty dollars (\$320.00) for any one lot. The residue of the cost of repair, if any, shall be paid out of other funds of the City.
3. The sidewalks to be repaired shall be constructed five (5) feet in width of Portland cement concrete. All work shall be carried out in accordance with the Illinois Department of Transportation "Standard Specifications for Road and Bridge Construction" adopted October 1, 1988, as revised, hereby incorporated herein, and shall be subject to the approval of the City Engineer.
4. The Director of Public Works shall mail a notice to the person who last paid the general taxes on the respective lots touching upon each sidewalk to be repaired notifying the owner of each lot of the passage of this ordinance and requiring the owner to construct or repair the specified sidewalk touching upon such lot within thirty (30) days of the mailing of the notice. Each such owner is hereby required to construct or repair that sidewalk as specified herein.

5. If the owner of any lot defaults, fails or refuses to construct or repair the specified sidewalk in accordance with this ordinance:
  - a. The City shall furnish the materials and construct or repair the specified sidewalk in accordance with this ordinance and may enter into a contract for furnishing materials and for the construction or repair as provided in 65 ILCS 5/11-84-1 et seq.
  - b. The Director of Public Works shall prepare a Special Tax list against those lots touching upon the sidewalk to be constructed or repaired ascertaining by computation the amount of special taxes and the annual installments thereof to be charged against each lot on account of the construction or repair in accordance with this ordinance.
6. The Special Tax shall be filed in the office of the Director of Finance and shall constitute a warrant for the collection of the Special Tax determined to be due from the respective lots. The Director of Finance shall collect the tax in accordance with the provisions of 65 ILCS 5/11-84-3.
7. The Special Tax levied by this ordinance shall be a lien upon the property against which they are charged from the date upon which a copy of this ordinance is recorded as provided in Section 9 hereof, which lien is discharged when the tax has been paid or the property has been sold pursuant to 65 ILCS 5/11-84-5.
8. Upon failure to collect the Special Tax as provided herein, the Director of Finance, on or before the first day of August in each year, shall make a written report of this Special Tax to the appropriate officer of Cook County in accordance with 65 ILCS 5/11-84-4.
9. A copy of this ordinance, duly certified, shall be delivered by the City Clerk to the Cook County Recorder of Deeds not less than thirty (30) days before the commencement of any construction by the City as specified herein.

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

BE IT FURTHER ORDAINED that the City Clerk is hereby authorized and directed to publish said Ordinance in pamphlet form according to law.
