

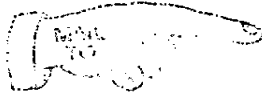

The powers expressly granted herein shall be limited to endorsement of the Notes or allonge thereto, execution of the Assignments/Transfers, of Lien evidencing assignment by the undersigned partnership/corporation/sole proprietorship of such Notes and the Security Instruments and all other liens securing the same, borrower applications and addendum thereto, borrower agreements and certificates and endorsements necessary to qualify such Loans for government insurance or guaranty or to evidence such qualification.

GRANTING AND GIVING unto its said attorney, full power and authority to do and perform each and every act necessary or appropriate to be done in the exercise of the foregoing powers as fully as the undersigned partnership/corporation/sole proprietorship might or could do if acting directly, with full power of substitution and revocation, hereby ratifying and confirming all that the said attorney shall lawfully do or cause to be done by virtue of this Special Power of Attorney.

THE powers granted herein shall commence on execution date shown below and unless sooner revoked expire at the close of business on December 31, 2000.

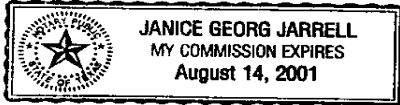
