IT IS HEREBY ORDERED:

1. Defendants Weldon Austin Allen, Josephine Allen, Weldon Anthony Allen, Weldon Allen and Associates, Ltd., d/b/a, Nirvana 2000 Hair Design & Makeup, a/k/a N2U Hair Salon, an Illinois corporation, and Salon Systems Inc., an Illinois corporation, and their officers, employees, agents, and lessees are permanently enjoined from conducting a hair care or beauty salon, and any and all business related activities arising out of the operation of said salon, on, or in connection with, Unit 713, 727 S. Dearborn Street, Chicago, Illinois, including, but not limited to, soliciting customers, placing or otherwise advertising in any manner whatsoever, receiving customers, performing services for customers, and/or building out facilities for conducting such business activities.
2. The Court shall retain jurisdiction to enforce the terms of this injunction.
