Parcel 1: That part of Block 1 in Baker's Subdivision of Lots 65 to 72, inclusive, and 75 to 80, inclusive, of the Town of Brighton in the Southeast Quarter of Section 36, Township 39 North, Range 13, East of the Third Principal Meridian, Cook County, Illinois, described as follows: beginning at the Southwesterly corner of Archer Avenue and South Western Avenue; Thence running South along the West line of South Western Avenue 200 feet; Thence running West to the Easterly line of the right of way of the Chicago Terminal Transfer Railroad Company; Thence running Northwesterly along the Easterly line of said right of way to the Southeasterly line of Archer Avenue; Thence running Northeasterly along the Southeasterly line of Archer Avenue to the place of beginning, excepting therefrom that part thereof conveyed to the City of Chicago, in Cook County, Illinois.
