## **NOTES**

- 1. The registered office may, but need not be the same as the principal office of the corporation. However, the registered-office-and-the-office-address-of-the-registered-agent must-be-the-same.

- 4. If the registered office is changed from one county to another, then the corporation must file with the recorder of deeds of the new county a certified copy of the articles of incorporation and a certified copy of the statement of change of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
