#### WITNESSETH:

WHEREAS, the Declaration has summitted certain real property to the provisions of that document which property is legally described in Exhibit A, attached hereto and incorporated herein by reference; and

WHEREAS, pursuant to Article X, Section 3 of the Declaration, the Declaration may be amended after the first eventy year period by an instrument executed and acknowledged by the Owners of not less than 75% of the Lots, including a recital in the amendment stating that the amendment has been executed and acknowledged by not less than said percentage; and

WHEREAS, the covenants were first recorded in 1978, more than twenty years prior to the date of this amendment; and

WHEREAS, this instrument has been executed and acknowledged by the required majority of the Owners.

NOW, THEREFORE, the Association adopts the recitals set forth above as part of this First Amendment to Declaration and hereby declares that the Declaration be and hereby is amended as follows:

Article VIII, Section 6 of the Declaration presently reads as follows:
