This First Amendment to Declaration is made and entered into this 15th day of June, 1999 by the required majority of members of the Wedgwood Commons Unit II Association, an Illinois not-for-profit corporation, and is an amendment to that certain Declaration of Covenants, Restrictions, Easements, Charges and Liens for the Wedgwood Commons Unit II Association (the "Declaration"), recorded in the office of the Recorder of Deeds of Cook County, Illinois as Document No. 24712655 and as may have been amended from time to time.

WITNESSETH:

WHEREAS, the Declaration has submitted certain real property to the provisions of that document which property is legally described in Exhibit A, attached hereto and incorporated herein by reference; and

WHEREAS, pursuant to Article X, Section 3 of the Declaration, the Declaration may be amended after the first twenty year period by an instrument executed and acknowledged by the Owners of not less than 75% of the Lots, including a recital in the amendment stating that the amendment has been executed and acknowledged by not less than said percentage; and

WHEREAS, the covenants were first recorded in 1978, more than twenty years prior to the date of this amendment; and

WHEREAS, this instrument has been executed and acknowledged by the required majority of the Owners.

NOW, THEREFORE, the Association adopts the recitals set forth above as part of this First Amendment to Declaration and hereby declares that the Declaration be and hereby is amended as follows:

Article VIII, Section 6 of the Declaration presently reads as follows:

Section 6. ANIMALS No animals, livestock or poultry of any kind shall be raised, bred or kept in any dwelling or any Lot, except that dogs, cats or other domesticated household pets may be kept, provided that they are not kept, bred or maintained for any commercial purpose and provided that not more than two pets, neither more than fifteen pounds each, in the aggregate may be kept in any such dwelling or Lot.

The undersigned, for the purposes set forth, hereby declare that the Declaration be and hereby is amended in regard to said Article VIII, Section 6 and said paragraph is deleted in its entirety and replaced with:

Section 6. ANIMALS No animals, livestock or poultry of any kind shall be raised, bred or kept in any dwelling or any Lot, except that dogs, cats or other domesticated household pets may be kept, provided that they are not kept, bred or maintained for any commercial purpose and provided that not more than two pets in the aggregate may be kept in any such dwelling or Lot. These pets will be subject to all reasonable rules and regulations of the Association.

* * * * *

Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.

This First Amendment to the Declaration is signed by Owners owning at least 75% of the Lots in the exercise of the power and authority conferred upon and vested in the Association and its members. The signatories hereby warrant that they possess full power and authority to execute this instrument.
