Grantor also hereby grants and assigns to Grantee, its successors and assigns, parking space A-7 as a limited common element as set forth and provided in the aforementioned Declaration of Condominium.

This Deed is subject to all rights, essements, covenants, restrictions, and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

And the Grantor, for itself and its successors, does core each, promise and agree, to and with the Grantee, that it has not done or suffered to be done, anything whereby the said premises hereby granted are, or may be, in any manner encumbered or charged, except as herein recited; and that the said premises, against all persons lawfully claiming, or to claim the same, by, through or under it, Grantor WILL WARRANT AND DEFEND, subject to the Permitted Exceptions appearing on Exhibit B which is attached hereto and made a part hereof.




#### PERMITTED EXCEPTIONS
