To Have and to Hold the same unto said parties of the second part, and to proper use, benefit and behoof forever of said party of the second part.

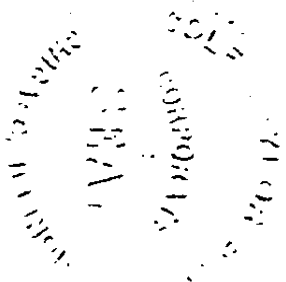

## LEGAL DESCRIPTION

### PARCEL 1:

Unit 205 in the 710 Oakton Condominium as delineated on a Survey of the following described land: Lot 1 in the plat of consolidation of the West 12-1/2 feet of Lot 2, and all of Lots 3, Lot 4 and the East 25 feet of Lot 5 in Block 6 in Merrill Ladd's Addition to Evanston, said addition being a subdivision of the North 13.49 acres of that part South of the North 48 links East of Ridge Road of the North West ¼ of Section 30, Township 41 North, Range 14, East of the Third Principal Meridian; which survey is attached as Exhibit "A" to the Declaration of Condominium recorded as Document Number 99323035, together with its undivided percentage interest in the common elements, all in Cook County, Illinois.

### PARCEL 2:

The right to the use of Parking Space P-23, a limited common element as delineated on the survey attached to the Declaration of Condominium aforesaid.

"Grantor also hereby grants to the Grantee, its Successors and Assigns, as rights and easements appurtenant to the above described Real Estate, the rights and easements for the benefit of said property set forth in the Declaration of Condominium, and Grantor reserves to itself, its Successors and Assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein."

"This deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein".

"The tenants of the unit has no right of first refusal."

General real estate taxes for the 2<sup>nd</sup> installment 1998 and subsequent years, private, public and utility easements including any easements established by or implied from the Declaration of Condominium or amendment thereto and limitations and conditions imposed by the Condominium Property Act.
