1. This cause is dismissed pursuant to the confidential settlement and mutual release which shall remain under seal and which is incorporated by reference herein.

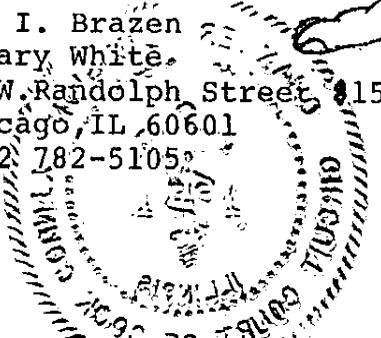
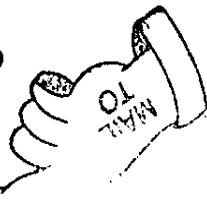
