MODIFICATION AND EXTENTION AGREEMENT

- 1. That irrespective of whether the Maturity Date of the Note was previously extended orally or in writing, the Maturity Date of the Note is hereby extended to August 1, 1999.
- 2. That the Maturity Date as described in the Mortgage and all the other Loan Documents, as modified orally or in writing from time to time, is hereby made consistent therewith.
- 3. In all other respects, the Note, the Mortgage, and the other Loan Agreements hereinbefore described shall remain unchanged and in full force and effect.
