17. INSURANCE. Mortgagee shall keep the Property insured against losses by fire, flood, theft and other hazards and risks reasonably associated with the Property due to its type and location. This insurance shall be maintained in the amounts and for the periods that Lender requires. The insurance carrier providing the insurance chosen by Mortgagee shall be chosen by Lender's approval, which shall not be unreasonably withheld. 


