The Village of Hanover Park, Illinois, an Illinois Municipal Corporation pursuant to the provisions of Section 14-74 of the Municipal Code of Hanover Park and 65 ILCS 5/11-20-7 hereby files a lien in its favor in the amount of **\$135.00** against the following described real estate:

Lot 31, block 62 in Hanover Highlands Unit number 8, being a subdivision of part of the northeast quarter of section 30, township 41 north, range 10 east of the third principal meridian in the Village of Hanover Park, Cook County, Illinois

Commonly known as **921 Yorkshire**, Hanover Park, Illinois.

That Section 14-70 through 14-75 of the Municipal Code of Hanover Park requires the owner or occupant of any property within the Village to cut all weeds on the property exceeding eight inches in height after notice or the Village shall cut the weeds and place a lien on the property.

That on **May 11, 1999**, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.


