TO
FINANCING STATEMENT

All of the Debtor's right, title and interest in the following property or types of property whether now existing on the property commonly known as 430 Palatine Road, Palatine, Illinois 60067 or hereafter arising or acquired wherever located:

- (i) all furniture, furnishings and equipment furnished by Debtor to tenants of the Real Estate or Improvements;
