 which shall run with the real property described on Exhibit "A" and
 shall be binding on all parties having any part thereof, their heirs,
 successors and assigns and shall insure to the benefit of each Owner
 thereof.
- 3. The Adjoining Property includes Common Area designated as Outlots A, B and C on Exhibit "A" to this Supplementary Declaration and upon the Plat of Subdivision for Fairway Club II recorded on April 23, 1998 as Document Number 982,28568 in the Office of the Recorder Cook County, Illinois.
