As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by Century 21, the balance of Seven-Hundred and Sixty-One Dollars & 79/100, (\$761.79), for which with interest, Claimant claims a lien on the Real Estate and on the monies or other considerations due or to become due from Owner to Century 21 Home Proprovements, Inc.
