AMENDMENT TO MORTGAGE

This Amendment is dated April 6, 1999, and is executed by The First National Bank of Chicago, either as original mortgagee or as assignee, ("Lender") and Jennifer Zeigler, now known as Jennifer Green and Jerome Green her husband

WHEREAS, Lender and Borrower wish to amend the Mortgage to conform to such amendments;

NOW, THEREFORE, for valuable consideration, the receipt of which is hereby acknowledged, Lender and Borrower agree as follows:

The maximum principal sum secured by this Mortgage shall be decreased to nineteen thousand seven hundred fifty & NO/100 Dollars (U.S. \$ 19,750.00), or the aggregate unpaid amount of all loans and any disbursements made by Lender pursuant to the Note as Amended, whichever is less.

Borrower waives all right of homestead exemption in the Property.

Except as specifically amended hereby, the Mortgage remains in full force and effect and is hereby ratified and confirmed in its entirety.

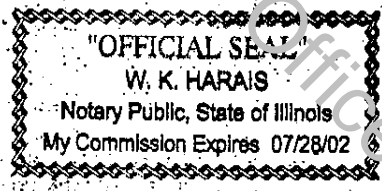
