"Just compensation" as used in this Order shall include, but not be limited to, the fair market value of the property acquired on the date of filing the Complaint for Condemnation, February 4, 1999.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

- A. That THREE THOUSAND TWO HUNDRED EIGHTY TWO DOLLARS AND 00/100 (\$3,252.00) is herein awarded by the Court to the owner or owners of and party or parties interested in said real property described herein as Parcel C as just compensation;
- B. That the Plaintiff, within one hundred twenty (120) days from the entry of this Order, pay to the County Freasurer of Cook County, Illinois, for the benefit of the Owner or Owners of Parcel C, the sur of THREE THOUSAND TWO HUNDRED EIGHTY TWO DOLLARS AND 00/100 (\$3,282.00) as full compensation for the taking of said parcel aforesaid plus 6% interest from the date of this Order, for the uses and purposes set forth in its Complaint herein.
- C. That upon payment as aforesaid, the Plaintiff herein shall be thereby vested with the fee simple absolute title to said Parcel of real property paid for by Plaintiff as aforesaid; and thereupon said Plaintiff, the CITY OF CHICAGO, shall be authorized and empowered to enter upon and take immediate possession of said real property so paid for. Upon the deposit by the City of the condemnation award and statutory interest, all liens, including tax liens, shall attach to the award and shall be extinguished and void as to the Property.
