FINAL JUDGMENT ORDER

THIS MATTER coming on to be heard on the Complaint of the
DEPARTMENT OF TRANSPORTATION OF THE STATE OF ILLINOIS, for and in
behalf of the People of the State of Illinois, to ascertain the
just compensation for taking property sought to be taken for public
purposes, as set forth in said Complaint;

And the Plaintiff appearing by NEIL F. HARTIGAN, Attorney General of the State of Illinois, and HERBERT L. HOLZMAN, Special Assistant Attorney General of the State of Illinois;

And it appearing to the Court that the Defendants in this proceeding have been served by process as provided by Statute or have entered their appearance;

That the Court has jurisdiction of the subject matter of this proceedings and of all parties hereto;

That the legal description of the property to be take is as follows:

The east 123 feet of a 66 foot strip of land southerly and adjoining to Chicago and Calumet Terminal Railway Company in Southeast 1/4 of the Northeast 1/4 of Section 2, Township 36 North, Range 14 East of the Third Principal Meridian, (said Chicago and Calumet Terminal Railway Company described as a 66 foot strip of land over the Southeast 1/4 of the Northeast 1/4 of Section 2, Township 36 North, Range 14 East of the Third Principal Meridian, the center line of which commences at a point 111.8 feet north of the southeast corner and runs north-westerly to a point 825.8 feet north of the southwest corner of said southeast 1/4 of the northeast 1/4 of said section), in Cook County, Illinois. (Except that portion lying within the Calumet Expressway.)

Containing 0.125 acres, more or less.

And it further appearing to the court that on January 15, 1988 the Court granted Plaintiff a permanent easement in parcel 0001PE and ordered the amount of the preliminary just compensation for said parcel to be \$1,650.00; the Plaintiff has deposited with the Cook County Treasurer, and that there were no damages to any remainder.

1. Just compensation to the owners and interested parties for the taking by Plaintiff of a permanent easement in Parcel 08S0001PE, which parcel is legally described in Exhibit A attached hereto and made a part hereof, is \$1,650.00.

2. There is no damage to any remainder as a result of the taking of said Parcel 08S0001PE.

3. Judgment is entered herein and that there is no just reason to delay its enforcement or an appeal from said judgment.
