**AN ORDINANCE AMENDING  
ORDINANCE NUMBER 99-036  
ANNEXING CERTAIN TERRITORY  
TO THE VILLAGE OF ARLINGTON HEIGHTS**

WHEREAS, on May 17, 1999, the President and Board of Trustees of the Village of Arlington Heights, approved Ordinance Number 99-036, annexing 750 North Rand Road into the Village; and

WHEREAS, it has been determined that the legal description contained within Ordinance Number 99-036, does not accurately describe the property which was intended to be annexed into the Village,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES AS FOLLOWS:

SECTION ONE: That the legal description contained within Ordinance Number 99-036, for the property commonly described as 750 North Rand Road, Arlington Heights, Illinois, be and is hereby replaced with the following:

That part of the West 1/2 of the Northwest 1/4 of Section 27, Township 42 North, Range 11 East of the Third Principal Meridian lying Southwesterly of the center line of Rand Road, in Cook County, Illinois.

and

That part of the West 1/2 of the Northeast 1/4 of Section 28, Township, 42 North, Range 11 East of the Third Principal Meridian lying Southwesterly of the center line of Rand Road, excepting therefrom the North 200 feet thereof and the South 660 feet thereof, in Cook County, Illinois.

and

All that part of the East 1/2 of the Northeast 1/4 of Section 28, Township 42 North, Range 11 East of the Third Principal Meridian lying Southwesterly of the center line of Rand Road, in Cook County, Illinois.

SECTION THREE: This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.


