That part of the West ½ of the Northeast ¼ of Section 28, Township, 42 North, Range 11 East of the Third Principal Meridian lying Southwesterly of the center line of Rand Road, excepting therefrom the North 200 feet thereof and the South 660 feet thereof, in Cook County, Illinois.

All that part of the East ½ of the Northeast ¼ of Section 28, Township 42 North, Range 11 East of the Third Principal Meridian lying Southwesterly of the center line of Rand Road, in Cook County, Illinois.
