in the total amount(s) of \$ 2,000.00 plus \$60.00 in court costs against defendant(s) Sang Wook Ra

Wook Ra shall stand as final judgment(s) and that leave for enforcement on said judgment(s) is granted plaintiff, City of Chicago, instanter.

2. A mandatory permanent injunction issue against defendant(s) Sang Wook Ra
his/her/their agents, heirs, successors or assigns, shall bring items # 3 & 4 into compliance within fourteen (14) days. Defendant shall bring items 1 & 2 into compliance with that (30 days). The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this mandatory permanent injunction.

3. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.

4. Plaintiff City of Chicago is hereby authorized to removed dangerous and hazardous premises.
