To purchase, sell, lease, convey, assign, pledge, hypothocate, mortgage and warrant, or otherwise deal with any or all real or personal property in which I have an interest, for such purposes and upon such terms and in such form as my attorney may choose, including, but not limited to property located in the Village of Arlington Heights, Cook County, State of Illinois, described as:
