#### **MEMORANDUM OF SUBLEASE**

- Pursuant to the terms of the Sublease, Sublandlord does demise and lease to 2. Subtenant the Property.
- The Term of the Sublease is for a period of fifty (50) years commencing on 3. August 31, 1999.
- Pursuant to the terms of the Sublease, Subtenant shall redevelop the Property 4. with a four (4) story building and basement, to be utilized as a first class, restaurant/retail facility with limited office uses for arts-related entities or administrative offices of Subtenant or restaurant/retail tenants occupying space at the Property.
- Pursuant to Section 19 of the Sublease, Sublandlord has conditionally assigned 5. to Subtenant its option to purchase fee simple title to the Property under Section 20.14 of the Ground Lease, as more fully set forth in the Sublease.
