**SUBORDINATION OF LIEN**

WHEREAS, Vincent Mills & Pamela Mills, ("Property Owner") executed a Mortgage or Deed of Trust (hereinafter the "Junior Mortgage"), in favor of Subordinating Lender dated 9/25/1998 and which was recorded in the Office of the Recorder of Cook County, Illinois, on 10/15/1998 as Document Number 98924665 encumbering the real estate and all buildings, structures, fixtures and improvements thereon (the "Premises") which has the street address of 3610 Edgewater, Hazel Crest, IL 60429 and is legally described on Exhibit A attached hereto and made a part hereof; and

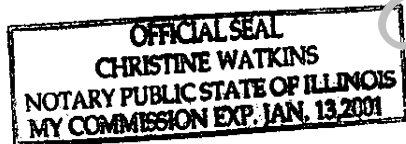


