IT IS FURTHER ORDERED that defendant Joseph Flaska's motions with respect to reduction of the verdicts are hereby granted as follows:

The verdict in favor of Jozef Sobclak in the amount of \$3,125,000 is hereby reduced to \$2,336,717.55

The verdict is favor of Anna Sobczak in the amount of \$475,000 is hereby reduced to \$280,000.

Judgment on said verdicts previously entered herein is hereby modified in accordance with these figures.
