SPECIAL WARRANTY DEED

PARCEL 2:

THE RIGHT TO THE USE OF GARAGE SPACE, G-120, A LIMITED COMMON ELEMENT, AS DELINEATED ON THE SURVEY ATTACHED TO THE AFORESAID DECLARATION.
