Kerrigan of the Village of Oak Lawn, County of Cook and State of IL for and in consideration of TEN and 00/100 DOLLARS, and other good and valuable consideration in hand paid, CONVEY(s) and WARRANT(s) unto Old Kent Bank, of 3101 West 95th Street, Evergreen Park, Illinois 60805 as Trustee under the provisions of a trust agreement dated September 29, 1992 and known as trust number 12691 (hereinafter referred to as "said trustee," regardless of the number of trustees,) and unto all and every successor or successors in trust under said trust agreement, the following described real estate in the County of Cook and State of Illinois, to Wit: *(See Legal Description Recd. attached as Page 3 hereto).*

The interest of each and every beneficiary hereunder and of all persons claiming under them or any of them shall be only in the earning, avails and proceeds arising from the sale or other disposition of said real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to said real estate as such, but only an interest in the earning, avails and proceeds thereof as aforesaid.



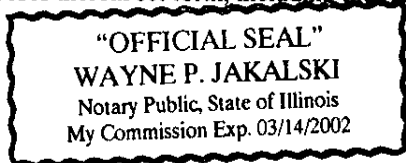


