IT IS HEREBY ORDERED THAT:

1. An agreed settlement/fine in the amount of \$ 100 plus ~~\$60.00 court costs~~ has been paid ^{within 30 days} ~~instantly~~ by the defendant in full satisfaction of the judgment in this cause, as evidenced by receipt # _____.
2. Defendant(s) Earnest Thompson his/her/their agents, heirs, successors or assigns are permanently enjoined and restrained from renting, leasing, using, or occupying the front unit of the subject premises until full compliance with the City of Chicago Codes as stated in this cause and further order of court.
3. Defendant shall schedule and permit interior inspections of the building to verify compliance with the terms of this order. Defendant shall call the inspector at 744- 2885 or send written request to the Department of Buildings within 7 days after each compliance date stated in this order.
4. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction, including the adjudication of contempt proceedings if the permanent injunction is violated which could result in the imposition of a fine and/or incarceration.
5. This order is final and appealable, the court finding ~~no~~ ^{no} cause or reason to delay its enforcement or appeal.
