My interest rate will never be greater than 10.450 % ("Cap"), except that following any sale or transfer of the property which secures repayment of this Note after the first interest rate Change Date, the maximum interest rate will be the higher of the Cap or 5 percentage ρc ints greater than the interest rate in effect at the time of such sale or transfer.

(E) Payment Change Dates
