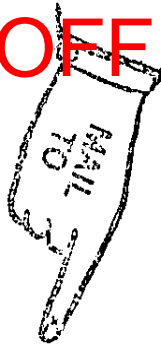

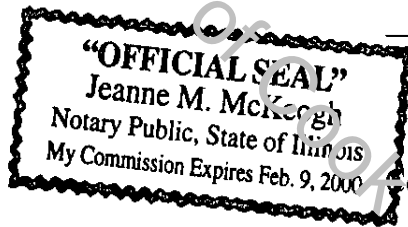

### Parcel 1:
